MEMORANDUM OF UNDERSTANDING

THIS DEED IS EXECUTED ON THIS DAY 07th JUNE - 2023 IN BETWEEN

**Sri. B. V. Papa Rao, S/o Kishan Rao, Age 68 Years, R/o 123, Lotus Enclave, Medchal, Telangana, representing Bogavelli R. Rao Pvt. Trust
(Herein after called Charity Donor).**

AND

M/s. Indian Red Cross Society Hanumakonda District Branch represented by its Chairman Dr.P.Vijayachander Reddy, S/o Suryaprakash Reddy, Age (63) years, Occupation: Medical Practitioner R/o Hanumakonda.

(Herein after called Receptionist/Donee).

Whereas the above Charity Donor with an intension to help the destitute children/orphans having found the Donee who is service oriented and doing selfless service expressed acceptance to serve the orphans, with a mutual understanding, clear mind and in utmost good faith have entered in to this MOU on this day 7th June - 2023 at Red Cross Society Hanumakonda District Branch with the following terms and conditions.

- 1) The Orphanage home shall be run in the name of Shri Late Bogavelli Rajeshwar Rao Memorial Orphanage.
- 2) The Donor agreed to pay Rs. 1.50 lakhs per annum per head for the day to day expenses and other amenities for each child.
- 3) The expenses will be paid by way of Cheque/DD issued in favor of Donee's Society on quarterly installments in advance payable on or before 7th of succeeding quarter.
- 4) The Donor has every right to inspect and check the premises to interact with the children at any time.
- 5) The Donee agreed to maintain orphanage home with at least (15) children and look after their upliftment and make them worthy citizens.
- 6) The Donee will determine the age group of orphans, criteria of selection and management of orphanage according to the established guidelines and in consultation with relevant Social Welfare Authorities of the District.
- 7) The Donee agrees to take care of orphanage home and provide with quality food, clothing and proper education for the inmates.
- 8) The Donee agrees to provide service to the inmates by way of employing Care Taker, Cook, Dhobi, Servant and Medical Assistance in need.
- 9) The Donee agrees to maintain detailed accounts for the expenditure incurred for the inmates out of the funds donated by the donor and produce before the Donor or his representative on demand.
- 10) Strength of the inmates beyond (15) may increase in consultation with the Donor and Donee subject to payment of expenses for the extra children.
- 11) The Donee will establish a monitoring committee to monitor the Orphanage in which a member nominated by the Donor be included.
- 12) There will be yearly review on the conditions/performance.
- 13) In case any misunderstanding develops in between both the parties that should be discussed in cool mind and amicably settled. Under any circumstances the orphanage home should not be closed spoiling the study of inmates in the middle of academic year.




- 14) The Donor with the experience and on satisfaction of proper maintenance of orphanage home, voluntarily agrees to consider to provide shelter permanently to the orphanage.
- 15) This MOU will be valid for 5 years and extendable on mutual consent.


